

Introduction & Objectives


To describe MDCH's activities to promote the uptake of adolescent vaccines and the use of the Michigan Care Improvement Registry (MCIR) among adolescent providers.

Adolescent Vaccine Coverage in MCIR, 13 through 17 year olds



Coverage with Tdap, MCV4, and 1- and 3dose HPV as measured in MCIR is currently consistent with NIS-Teen, 2008 estimates for Michigan. Seasonal influenza and 2009 H1N1 coverage remain low in this age group.

Settings Where Teen Vaccines Are Administered



Almost 94% of teen vaccines administered to 13-17 year olds are being given in traditional provider sites; only a small fraction are being given in alternate sites.

Changes to School Rules


Beginning January 1, 2010, all children 11-18 years of age who are changing school districts or who are enrolled in 6th grade are required to have received:

- 2 doses of varicella (Var) vaccine or evidence of immunity
- 1 dose of meningococcal (MCV4 or MPSV4) vaccine
- 1 dose of tetanus/diphtheria/acellular pertussis (Tdap) vaccine if 5 years have passed since the last dose of tetanus/diphtheria vaccine (DTaP, Td or DT)

Plan to monitor the impact on HPV vaccination rates
